


Parent survey analysis – Remote learning provision.

98% are neutral, agree or above that communication has been clear, concise and effective.


Only 2% disagreed or below to communication being effective.

97% are neutral, agree or above that there was a member of staff to support with educational concerns.


Only 3% disagreed or below that they were not support with educational concerns.

The main school office has been contactable during normal school hours to help and support. The enquiries email was also used well throughout the Lockdown by all parties across the school. Teachers have been contactable via the main office but also through specific class emails – this has been the main point of contact by parents asking questions, sharing concerns or issues and sending in work. Purple Mash blogs also holds the ability for the children to contact teachers and use internal Purple Mash emails.

The school is demonstrating positive awareness about my child's mental health and well-being as the school continues to offer provision.


94% are neutral, agree or above that the school showed an awareness of the mental health and wellbeing of their children.

95% are neutral, agree or above that the school signposted their child to the appropriate support.


However, only 5% disagreed that their child did not get signposted to the appropriate support.

Mental Health was a focus each week during lockdown. 'Staying active' ideas were suggested throughout; collective worship and prayer opportunities were given each day. A mental and emotional wellbeing blog was also created to give advice to parents throughout lockdown – this provided links and support available across Birmingham. Those in school were also given the same opportunities.

99% agree or above that they understood the school's expectations with regards to their child's home learning.


Only 1% disagreed that they did not know the expectations for their child's home learning.

Remote Education Provision for Parents documentation was shared with parents and available on the school's website. The blogs set clear time frames and lesson activities each day. A large amount of work was received through the Purple Mash platform and the class emails. Additional challenges and activities were shared through the Newsletter and highlighted on the blogs.

7% of parents were not concerned regarding the impact of time away of school on education.

Parents are naturally concerned regarding the impact of lockdown on children's education. Remote Education aimed at keeping children in touch with the school's curriculum as much as possible and the quality and volume of work was excellent across all year groups. On return to school a full curriculum would resume, baseline testing would take place but there is still a focus on mental and emotional wellbeing.

8% of parents stated that their children did not manage the work set by the school.

Differentiated work was set and suggested across all year groups. This was well embraced across classes with children often pushing themselves onto other set work. Differentiated blogs were created and set for individuals where needed. Marking and feedback gave children comments on next steps and success of work, additional work was also set where needed.

The resources required for home learning are easily accessible.

96% are neutral, agree or above that the resources required for home learning were easily accessible


Only 4% disagreed on this matter.

Purple Mash software was widely used across the school along with the Doodle Apps. Teaching videos, reading videos and assemblies were widely watched and commented on. Computers were given to parents who needed access to the technology as well as SIM cards from Vodafone to those who needed internet support. Documentation was uploaded and shared on blogs and paper packs created for those who needed it although this was only used by a small few.


100% agree or above that the school's risk assessment and procedures kept children as safe as possible.


56% of children feel excited, 32% feel ok, and 12% feel anxious about going back to school.

We were delighted to see so many excited to return to school however realise that the nerves would set in on their return. Emotion Stations have been set up within school to enable children to communicate their feelings. Wellbeing and Rainbows groups have been set to further support children in school. Children will be monitored throughout the coming weeks and months and we ask parents to communicate with the school if there are concerns from school.
